In accordance with the provisions of Para.

(A) of Article (42) of the Constitution.

The Revolutionary Command Council have decided to promulgate the following Law:

Law No. (15) of 2000

The First Amendment to the Law of Arms
No. (13) of 1992

Article -1-

The text of Article (4) of the law of Arms No. (13) of 1992, shall be repealed and substituted by the following.

"Article 4

- Firstly: It is not permissible to import or export the fire Arms or its spare parts or its ammunitions or manufacturing same.
- Secondly It is not permissible to possess or bear the Fire Arms or selling or repairing it unless by a licence from issuance authority.
- Thirdly: A- It is permissible by a licence from the issuance authority to open shops for selling the Fire Arms and its ammunitions from possessions of the citizens being locally existed by a licence from the issuance authority.
- B- It is permissible for the licensed to possess A Fire Arm to display his arm for selling on the shops stipulated in Para. (A) of this Item."

Article - 2-

The following shall be added to Article (5) of the Law and it shall be item Fifthly thereto:

Fifthly: A special licence for openning a shop to sell Fire Arms.

Article -3-

Firstly: Para. (F) of Item Firstly of Article (6) of the law shall be deleted.

- Secondly The text of Para. (G) of Item Firstly of Article (6) of the law shall be deleted and substituted by the following.
- "G- He should be technically entitled to bear the fir Arms or practising the profession of selling or the repairing under a test to be carried out by the authority to be defined by the issuance authority.

Article - 4 -

- Firstly: The text of Para. (b) of Item Firstly of Article (8) of the Law shall be deleted and substituted by the following:-
- "B. To come into force for a period of (5) five years as from the beginning of the month of January of the year issued therein except the licences stipulated in items "Secondly" and "Fifthly" of Article (5) of the Law so it shall be operated for one year beginning from the first day of the month itself.
- Secondly: The following shall be added to Article
 (8) of the Law and shall be the items
 (Thirdly), Fourthly and Fifthly thereto.
- Thirdly: There shall be collected for granting and renewing the two licences stipulated in (Secondly) and (Fifthly) of Article (5) of the law, the annual fees decided in the schedule attached to the law.
- Fourthly: The revenues of the fees being collected against granting and renewing, the licence of openning the shop for selling the fire Arms and the licence of openning a shop to repaire it stipulated in the schedule of duties enclosed to the law shall be distributed according to the following rates:
- A- (30%) thirty percent as final revenue to the Public Treasury,
