

# RESOLUTIONS

## RESOLUTION NO. (563)

In accordance with the provisions of Para. (a) of Article (42) of the Constitution,

The Revolutionary Command Council have decided in their session held on 29.6.1986, the following :-

- 1 - Two annual schedules shall be dependable when pensioning the state civil servants off, whose retirement is made according to a Republican Ordinance. The first schedule shall be issued in the beginning of January and the second in the beginning of July of each year.
- 2 - The competent Ministry or the authority not connected with a Ministry shall approach the Presidency Diwan concerning the retirement of their civil servants included by this Resolution on such appropriate period before the date specified for the issuance of any of both schedules.
- 3 - The provisions of this Resolution shall be applied to all cases of pensioning off stipulated in the civil retirement laws whether the pensioning off was permissive or compulsive. A civil servant who must be legally pensioned off before the date of issuance of any of the schedules shall be considered in service and keep all his rights and powers pending his pensioning off according to the provision of this Resolution.
- 4 - The President of the Republic may, according to the public interest requirements, pension any civil servant off as an exception from the provisions of this Resolution.
- 5 - This Resolution shall come into force from the date of its publication in the Official Gazette.
