

## RESOLUTIONS

### RESOLUTION No. (158)

Date : 15th. Dhul Qi'da, 1411 H.

29-5-1991 A.D.

In accordance with the provisions of Para. (A) of Article (42) of the Constitution.

The Revolutionary Command Council have decided the following :-

Firstly : The Revolutionary Command Council Resolution No. (56) of 5-3-1991 shall be cancelled.

Secondly : The citizens shall be exempted from paying fees of water, electric and telephone for the period from 17-1-1991 to 1-6-1991.

Thirdly : The competent Ministers and authorities concerned shall undertake the execution of this Resolution.

### RESOLUTION No. (173)

Date : 26th. Dhul Qi'da, 1411 H.

9-6-1991 A.D.

In accordance with the provisions of Para. (A) of Article (42) of the Constitution,

The Revolutionary Command Council have decided the following :-

Firstly : Resolution of the Revolutionary Command Council No. (430) of 17.6.1987 shall be repealed and the Baghdad Governorate (as abolished) shall be restored with its full rights, obligations, tasks and its previous administrative units connected thereto before its abolishment, with taking into account the provisions of Para. (Secondly) of this Resolution.

Secondly 1- Qadha (Abu Ghraib) shall remain of its current administrative level and Nahiyat (Al Nasser and Salam) shall be attached with it, and Nahiyat (Al - Karma) shall be disconnected with all its administrative border from the mentioned Qadha and shall be attached with Falluja Qadha Anbar Governorate.

2- The connection of Nahiyat (Al - Tarmiya) shall remain in its full administrative borders with Qadha (Al - Faris) in Salaheddin Governorate.

3- The connection of Nahiyat (Al - Latifiya) shall be disconnected with its full administrative border from Al - Mahmudiya Qadha and attached with Al - Mahaweel Qadha, Babylon Governorate.

Thirdly : Minister of Interior shall be authorized the following powers :

1- Amending the administrative borders the Qadhas and Nawahi within the borders of Baghdad Governorate, its borders with the Borders of the governorates surrounding it according to the exigencies of the Public Interest.

2- Issuing the instructions to facilitate the execution of this Resolution.

Fourthly : This Resolution shall be operated after elapsing 30 days from the date of its publication in the Official Gazette.
